PURPOSE: Pitch Deck, Story Map, and Next Steps

DISCUSSION:

Pitch Deck:

- Shared latest version that REH, BL, and JC have been working on.
- Slide 5: Discussed icons representing complexity. Looking better. Needing an appropriate icon for the Cultural aspects of complexity... and the moose's antlers are on backwards.
- In-depth discussion about Slide 15. Red line at east end of image needs to be adjusted to the intersection of Sunrise/Quartz Creek Rd and then bend along the roadway white line to the eastern-most driveway of the Transfer Station. Do not go down Quartz Creek Road as currently imaged.
- Dial with complex components on slide 15 may be larger but not smaller.
- Nearly complete.

Story Map:

- Safety Path on the maps needs to be accurate representation, on south from Quartz Creek
 Rd east but on the north side throughout the rest of its length
- Need to add text for the slides including Who We Are, Transportation Corridor.
- E.g. Cooper Creek represents one of the most complex sections of route. Drone videos or other information can be added to the text/image box.
- Transportation Corridor
- Maps will overlay
- Connecting Recreation: introduce "tails" from Safety Path to trails to indicate how the Safety Path will connect the trails or fishing spots, or boat launches, etc.
- Anadromous streams: add wetlands and upland feeder streams via color to show the sensitivity of the geography surrounding the anadromous waters.

• B. Lexmond willing to help with Story Map once we get it to a further edition with more features and text boxes filled-in.

Next Steps:

- See list of key individuals and work on where we are at in raising our connection with them. Come up with specific action items for each person (how specifically should we work to bring them in to get them on board?)
- Do we want RTCA assistance in making any of the particular connections?
